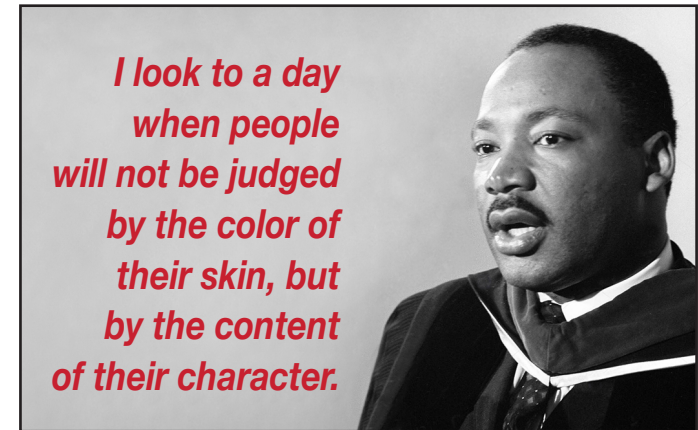

Critical Race Theory

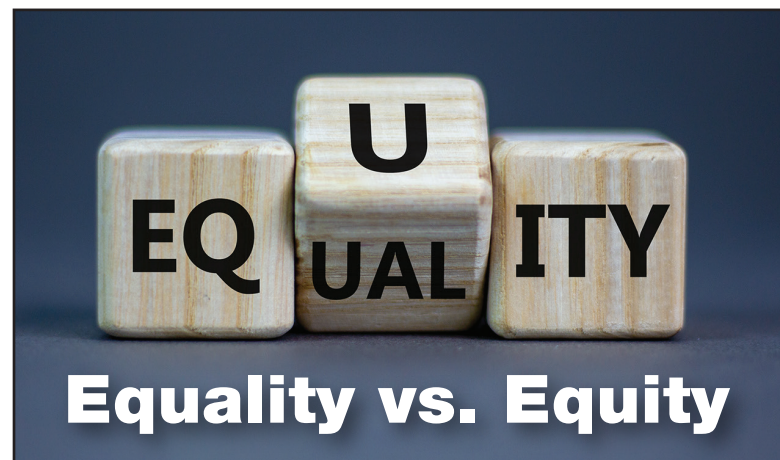

CRT teaches the concepts of **race essentialism** and **race-based guilt**. *“That white Americans can be reduced to the quality of ‘whiteness’ and must undergo rigorous reeducation to atone for their inborn white privilege, white fragility, and internalized racial superiority.”* Public schools are using race and gender to divide students and faculty/staff based on **diversity**, **equity** and **inclusion**. These so-called *“affinity spaces”* **segregate** students and faculty/staff and are in violation of the constitution and state and federal laws.

Race indoctrination also promotes the differences between Equality and Equity. **Equality** means education is “the same” for everyone. Are circumstances different for the larger number of whites living in poverty; dysfunctional families; dangerous and declining cities and neighborhoods? The answer is “**no**”, there is no difference in circumstances. They say blacks are discriminated against by whites. But, that also is not true. Black on black violence is a testament to that fact; and, a sad reminder of the failed policies of Democrats running inner-cities they never talk about. **They're hypocrites!**

The goal is to **empower students** to “*refuse to accept the dominant ideology and their subordinate status and take actions to redistribute social power more equitably*”.



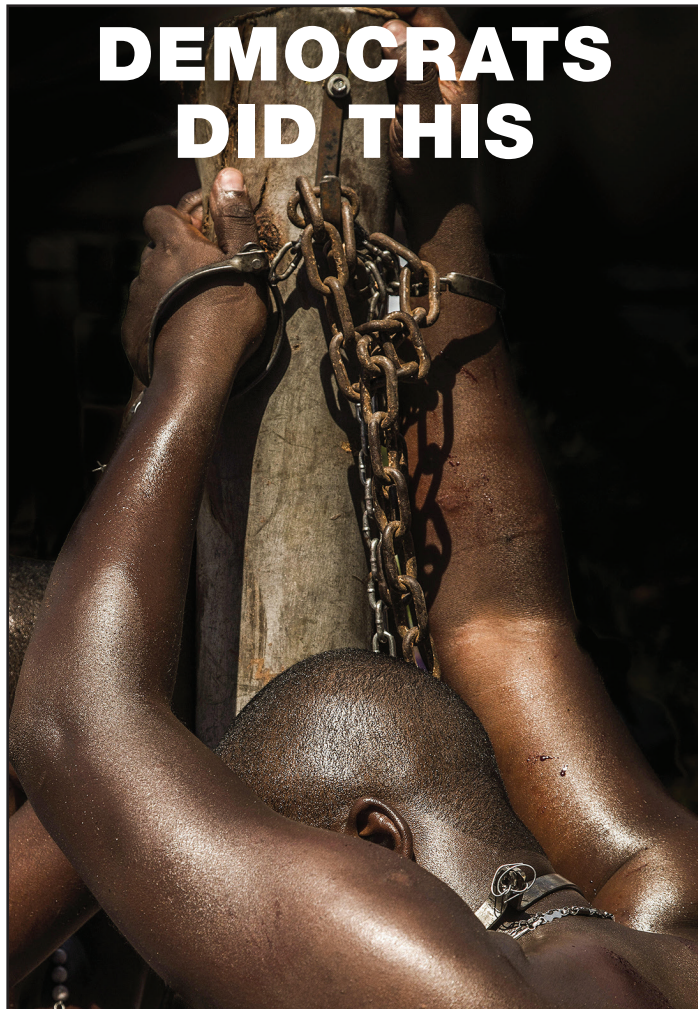

Ben was born into poverty in Detroit.

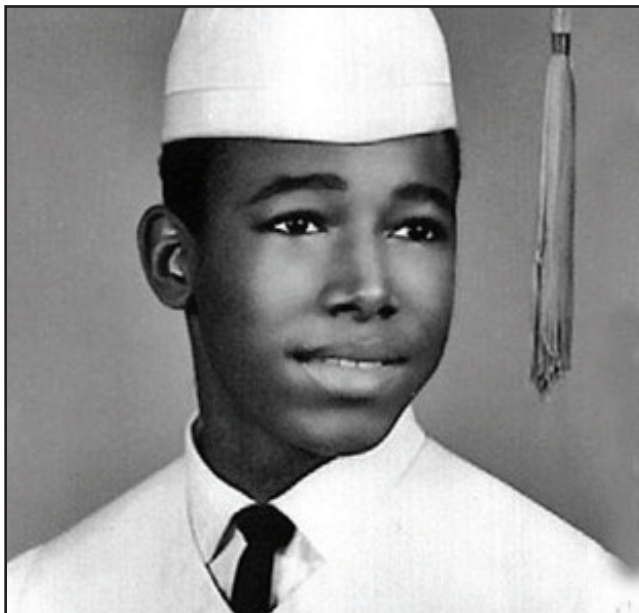

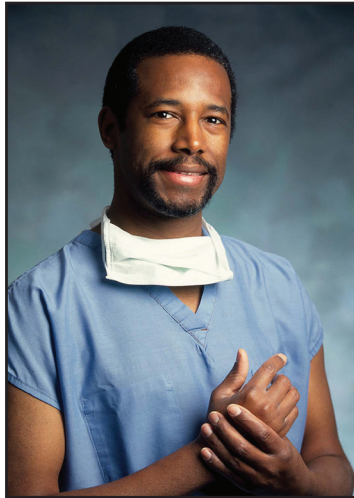
Graduated with HONORS

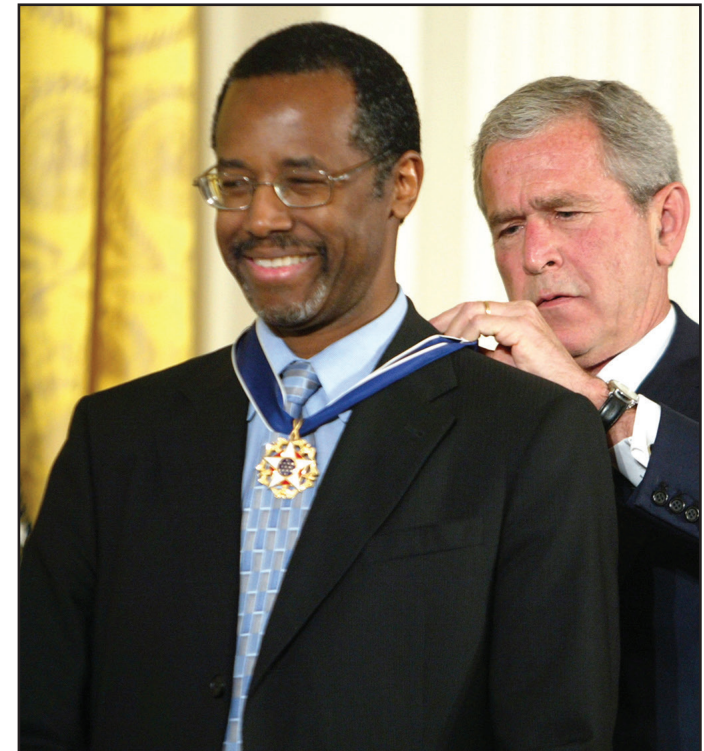
Ben received many awards for public service, including the **Presidential Medal of Freedom**.

Faith ... Community ... Life ... Liberty. These **core values** should be taught in our schools, as they were in the past, as Civics and History courses.

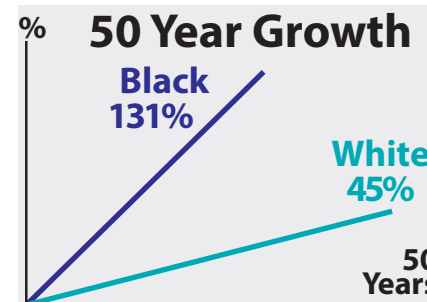
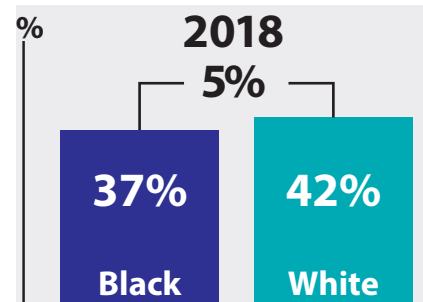
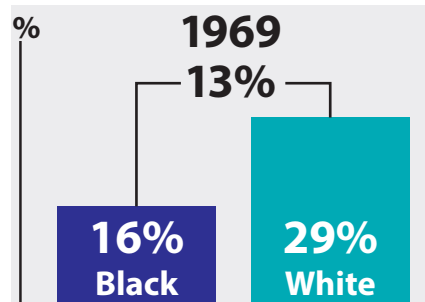

Where's the Oppression? There isn't any.

When Ben started at Yale in 1969, the college enrollment rate for Blacks was **16%**; as compared to Whites at **29%** — a **13% difference**. By the year 2018, the rate for Blacks increased to **37%**; and for Whites **42%** — a **5% difference**. *Black enrollments have grown by 131%; and Whites by only 45% in 50 years.*

When we include Asians and Hispanics into the overall enrollment rate, we must ask the questions: ***Are Asians and Hispanics privileged? Are they oppressing Blacks? Of course not!*** In fact, they are more disadvantaged than Blacks by language barriers and their ability to assimilate into our society. We have seen the bigotry and attacks against Asians, and to a lesser degree Hispanics, by Black Lives Matter, Antifa, and other radical leftist hate groups.

Discrimination is not exclusive to Blacks. It afflicts humanity like cancer that must be treated and removed. America has done more to promote racial equality than any other nation; and, we're not finished.

*So, why are Blacks allowing Fascists and Bigots to use them as “**Victims**” to divide our country?* The answer is their **intergenerational dependency on welfare**, which began as the “Aid to Dependent Children” program, that was later renamed “Aid to Families with Dependent Children” (AFDC), in 1962.

AFDC offers a “**financial incentive** for women **to have children** outside of wedlock and remain unmarried”. Prior to its enactment, nearly **80%** of Black families were **two-parent families**. That number now is **20%**, **1 in 5** that have a father at home for children growing up. There is no masculine role model; male guidance and discipline; no work ethic. Just hurt and anger caused by betrayal and abandonment of a non-caring father.

Black problems are not racial, but cultural; and Democrats just watch as their inner-cities implode with lawless crime; drug addiction; and poverty. Since the 1960's, Black incarcerations have risen to **40%**. Abortions account for **38%** of babies murdered by Planned Parenthood (*650 per day; 5 times more than Whites*).

Government handouts have also enslaved Native Americans, forcing them to live in squalor and poverty on reservations. The Tribes that "Opted Out" are running successful businesses; live in beautiful housing and communities with some of the best Charter schools in the country that they built and operate.

Welfare never accomplishes what it is intended to do because it gives the recipient a "hand-out", and not a "hand-up" to be self-reliant. Ronald Reagan captured the failure of our Welfare System in the following narrative, the: "Welfare Queen"

"There's a woman in Chicago. She has 80 names, 30 addressees, 12 Social Security cards and is collecting veterans' benefits on four nonexistent deceased husbands. She's got Medicaid, is getting food stamps and welfare under each of her names. Her tax-free cash income alone is \$150,000."

Blacks need to have hope, not anger and hate. Our country must unite and stop the destructive division, that has no benefit and draws us further apart.
